Dear Mayor-elect,

In the name of the Open Government Partnership (OGP), I like to extend our warmest regards. OGP was founded by Heads of State and Civil Society leaders at the UN General Assembly in 2011. OGP's vision is that more governments become sustainably more transparent, more accountable, and more responsive to their citizens with the ultimate goal of improving the quality of public policies and services.

During the past ten years, 76 countries and more than 100 local governments have joined OGP, along with thousands of civil society organizations and the support of multilateral partners such as the OECD, UNDP, the European Commission, and the World Bank. Through OGP, governments and civil society identify the key transparency, participation, and accountability challenges they face and make concrete commitments to address them. Together, they see OGP as an opportunity for cross-country peer learning and exchange, furthermore, a global platform to strengthen their commitment to the values and principles of open government.

Ecuador has been a national member of OGP since 2018, and today is implementing its [Second Action Plan 2022 - 2024 with 15 commitments.](#)

**Quito** applied to become a member of OGP Local in **2020** and was part of the selected few who were accepted due to its ambition to build a more open, inclusive, and equitable city by adopting ambitious genuine government reforms in line with our unique global platform. The other local member from Ecuador is Santo Domingo de los Tsachilas, currently developing their second action plan.

The first action plan from Quito was concerted with academic institutions like the Escuela Politécnica Nacional, Universidad Central del Ecuador, Universidad Hemisferios, and Civil Society Organizations like Fundación Ciudadanía y Desarrollo, Movimiento Ciudadano por la Democracia, Corporación Diálogos por la Democracia, Cooperativa de Vivienda Rural Oficiales de la Policía Nacional, among others.

We encourage Quito's current work with non-governmental actors to continue for the co-creation of the second action plan and congratulate it on completing its first action plan, including commitments like a program to promote local economic development processes, develop training and education processes for effective citizen participation, repowering the geoportal, strengthen the information management and publication in the open government portal, and the

implementation of the international parameters of Open Parliament in the direction of the Quito Metropolitan Council.

We are still waiting to receive the end-of-commitment reports and the final learning exercise of this first action plan, two documents with which OGP can build evidence and learning back to our members. I kindly ask you for your support in completing this pending reports.

We firmly believe that leaders who embrace innovation and pursue ambitious open government reforms are the driving force behind transformative change. That is why we encourage you to continue being part of this global network of local governments, civil society organizations, and academia, who are passionate about changing the government culture and see OGP as a platform to advance this work. We stand ready to support Quito in your journey to becoming more open.

We invite you to send your **Letter of Support** (as stated in our [Handbook](#)) to showcase your commitment to the [OGP Values](#) and being a part of our unique Partnership and the open government global community.

Finally, I want to take this opportunity to extend an invitation to participate in the **8th OGP Global Summit**, organized by the government of Estonia on September 5-7. This will be a major opportunity to connect with other OGP members from the global community and as local leaders participate in the Local Assembly, the first political meeting where heads of local government and civil society convene in a Summit. We can provide further information if you are keen to participate.
